## Financial Report – Dale Erickson

Treasurer Dale Erickson presented primarily from the document entitled "Budget for Ministry: Summary Comparison" (attached). He noted that while the adopted 2020 budget included a deficit of \$22, 573, we ended the year instead with a surplus of \$7,711. Similarly, the budget proposed for 2021 includes a deficit of \$31,110, which we hope to reduce mid-year through increased income, reduced expenses or a combination of both.

There was a series of questions by Scott Black regarding the PPP loan: 1) Did it figure into the Budget Summary? 2) Are we planning to repay it? 3) Will we be pursuing a second round of PPP loans?

Dale explained that 1) since the PPP was currently considered a loan, it figures on the detail Year-End Financial Report (attached) as an asset, but not on the budget summary because it is not yet considered income. 2) We are in the process of applying to have the loan forgiven, and assume that it will be; if we do not qualify for such forgiveness, we will then plan to repay the loan. 3) At present, we are not planning to apply for a second round of PPP loans.

Motion to approve the 2021 budget as presented: Moved- Priscilla Berg. Seconded - Nancy Klemz. Approved by unanimous voice vote.

## Member Q & A's re COVID and Christ the King re-opening

- **Q -1:** When will we re-start in-person worship?  
**A:** There is no set date to re-open at this time. As we look forward: the availability of and ability to get vaccines, a continuation in the decrease in COVID cases, and the recommendations of the Department of Health and the Governor's office, we are currently in Phase 2. This will adjust to changing circumstances. We are planning, if the weather cooperates, on having in-person opportunities during Holy Week with a Palm Sunday Procession to Hanson Park, Good Friday stations in the parking lot, and perhaps an outdoor Sunrise service for Easter. Be aware that CtK's COVID Response Team meets regularly to discuss the "current" situation and guidelines. It is that group (made up of Faith Community Nurses, the Staff Exec team and the Council Exec Committee) who is responsible for adjusting the "dial" as determined by the situation at the time. No password is required to access the website.
- **Q -2:** Will CtK continue having worship and events on a Virtual basis after we do re-open?
- **A:** Yes. We hope to begin livestreaming in the near future, and continue livestreaming our in-person worship, if possible. Thanks to a Foundation Grant, we have been able to purchase the necessary equipment for livestreaming.
